**European Communities Regulation No. 183/2005 of the  
European Parliament and of the Council of 12 January 2005 laying down  
requirements for Feed Hygiene (SI 22 of 2020)**

Dear Mr. Kilroe

I refer to your application to register as a Haulier of Feed and Storekeeper under the above Regulations. Enclosed please find Registration Licence.

**Please note the following in relation to feed haulage and requirements at inspection:**

Registered hauliers of feed are subject to inspection by Department Officers at Feed Mills, Ports or at their own Premises/Depots.

Trailers used to haul feed must be of sound structure and in good condition. They must be easily cleaned and records of cleaning must be maintained and available for inspection. The trailer must be fitted with a well maintained good quality cover. **Trailers used to haul feed must not be used to haul products containing animal proteins or other products that could contaminate the feed.**

The products listed in Annex III of Regulation (EC) No. 767/2009 must not be carried in trailers used to haul feed (for ease of reference a copy of Annex III is also enclosed).

The following records must be kept and made available to the inspecting Department Officer on request:

- Inspection/Cleaning records
- Records of previous loads – at least 3
- Traceability of deliveries – place of collection and delivery of the loads
- HACCP Procedures
- Code of Practice
